II. BEIRUT, LEBANON — COMPLETE SESSION RECORD (May–July 2025)

Ten sessions from Beirut, Lebanon are recorded in the full dataset across the period May 27–July 18, 2025. This is the complete Beirut record — no sessions have been omitted. Sessions 1–3 are the primary evidentiary focus; Sessions 4–10 are included for completeness.

† Sessions 4–6: Raw CEST timestamps read 00:00, 00:01, 00:17 on June 23 in the GA4 export (Spain CEST). Corrected to June 22 EDT. All three sessions accessed the same article within a 17-minute window.

Article content — Sessions 1–3: The article accessed by all three May 27 Beirut sessions, *Cyberlux in Receivership: The Fantasy Is Finally Over*, published May 24, 2025, named Bilal “Bill” Maadarani by name in his capacity as Chief Revenue Officer and discussed the reputational consequences of his association with Cyberlux. The article explicitly noted that his knowledge of the back-office financial manoeuvring was “unclear.”

Sequence — May 27, 2025: Last Beirut session: 1:34 PM EDT. @RacketeerX first post: approximately 3:20 PM EDT (1 hour 46 minutes later). Maadarani WhatsApp message: 4:32 PM EDT (2 hours 58 minutes after the last Beirut session; during the active @RacketeerX campaign).

III. PARIS, FRANCE — MAY 27, 2025

Multiple sessions were recorded from Paris, France on May 27, 2025, spanning approximately 10:13 AM to 1:49 PM local Paris time (CEST). All sessions accessed the same article: *Cyberlux in Receivership: The Fantasy Is Finally Over*. Individual session-level rows are not extracted in this exhibit; the window and article accessed are confirmed from the full dataset.

Geographic context: Carson John Tucker, sole director and PSC of G2G Global Ltd. (recipient of \$994,460 in Cyberlux-disbursed FMF funds, October 16, 2023), maintains a documented residential address at 49 Rue du Val d’Osne, 3ME, Saint-Maurice, Val-de-Marne 94410, France — a commune immediately southeast of Paris. No attribution of the Paris sessions to any identified individual is made in this exhibit. The geographic coincidence and timing are presented as documented facts.

Sequence note: The Paris sessions (ending approximately 7:49 AM EDT) preceded both the Beirut sessions (beginning 12:59 PM EDT) and the @RacketeerX campaign launch (approximately 3:20 PM EDT).

IV. VISTA, CALIFORNIA — MAY 27, 2025 (DATRON WORLD COMMUNICATIONS, INC.)

Vista, California is the city of Datron World Communications, Inc. headquarters — 995 Joshua Way, Suite A, Vista, CA 92081 — the wholly owned subsidiary of Cyberlux Corporation. Fourteen sessions from Vista are recorded on May 27, 2025. Key sessions are summarized below; all times EDT.

Vista sessions span 1:33 PM to 7:54 PM EDT on May 27, 2025 — across the same period as the @RacketeerX campaign (approximately 3:20 PM–9:55 PM EDT) and the Maadarani WhatsApp message (4:32 PM EDT). Vista total for 2025: 77 sessions across the full year. GA4 city identification does not identify specific devices, users, or premises within Vista.

V. TIMEZONE NOTE

The GA4 property for jacksonholt.com is configured in Spain CEST (UTC+2). The dateHourMinute export field records timestamps in that timezone. Two conversion methods are possible:

The UTC-4 method produces the 1 hour 46 minute elapsed time documented in Section IV.B of the Declaration and is used throughout this proceeding for consistency with prior filings. Raw CEST timestamps are provided in every table above so the Court may apply either method independently.
