**DECLARATION OF JAMES CURTIN IN SUPPORT OF
PLAINTIFF’S OPPOSITION TO DEFENDANT HII MISSION
TECHNOLOGIES CORPORATION’S MOTION TO DISMISS**

I, James Curtin, declare as follows:

1. I am the Plaintiff in this action and appear pro se. I am over the age of eighteen and competent to make this declaration. The facts stated in this declaration are within my personal knowledge, and if called as a witness I could and would testify competently to them.
2. I submit this declaration to authenticate Exhibits A and B to Plaintiff’s Opposition to Defendant HII Mission Technologies Corporation’s Motion to Dismiss.
3. Exhibit A is a true and correct copy of electronic communications among Mark D. Schmidt and others, exchanged in or about March and April 2022, comprising 139 pages. I received Exhibit A directly from Anthony Gonzalez of the ARG Group, a participant in the communications it records, in or about April 2025. Mr. Gonzalez has himself attested, in the interpleader proceeding, to the existence of additional such messages.
4. The communications attached as Exhibit A are the same communications referenced in Plaintiff’s First Amended Complaint at paragraphs 74 and 76(c).

5. I have made no alteration, edit, addition, or deletion to the content of Exhibit A.
6. Exhibit B is a true and correct copy of an investigative article I researched, authored, and published under the pen name Jackson Holt, titled "The Poorly Written Contract that Cost Taxpayers at Least \$48 Million." I published it on May 9, 2026 at theyberluxfiles.com. It is the article identified as entry 23 in the timeline of my investigative articles attached as Exhibit G to the First Amended Complaint, and it includes a hyperlink to a companion analysis I authored, titled "K8: Not Fit for Purpose."
7. Since on or about May 3, 2026, the domain jacksonholt.com has redirected to theyberluxfiles.com, where my investigative work is currently published.
